- A length of unnamed footpath. It commences 31 metres south west of the north eastern corner of Graham Court extending in a south easterly direction for a distance of 6 metres.

10.	County Councillor's Reports	 Cllr Simon Wilson Report Speeding - This has been a massive concern across the Parish this month. Speed survey at Findon Hill has been completed and the data is being compiled to see what the results say. Initial indications from Dave Battensby have correlated some speeding in the times raised by residents, however this needs to be verified and exact numbers worked out. I have also requested a speed survey on Plawsworth Road or some sort of police action. I understand the police have got a new method of dealing with speeding and one of the main areas identified is Daisy Hill. Crosslane - have been told informally that designs for speed measures there will be speed bumps (due to vision displays etc) and therefore this will be looking to be moved forward, Persimmons Homes will be paying for this. Bottom building site, is still an ongoing issue and trying to work out exactly what is going on with it, COVID situation not helping either. LA Governor – to confirm if councillors Smith and Ludlow have heard anything? Raised concerns about noise at Lavender Gardens and the development there. Updated COVID restrictions - obviously, everything is all over at the minute. However, I am still continuing to check if there are any vulnerable individuals who may not have support bubbles or people to do their shopping etc. Any further info is much obliged. White Lines at Fulforth - was told they would be done by end of September but had no confirmation so asking our officers again. 	SW	
		Demolition of Unit 2 is scheduled to take place after the 12 th October once Northern Power Grid remove a power box. Sacriston Youth Project have submitted a planning application for the old police station for change of use and associated building works. Live Well North East are ploughing ahead and are way		

ahead of the other tenants following a successful bid of approx. £100K from Sport England which they submitted last summer with support from Gemma O'Brien. They have already transformed one of their units into The Den which looks amazing and the Sport England grant will transform their other units into amazing spaces too.

All works that take place on site have to be agreed by DCC Assets team in advance and strict rules have to be followed when appointing contractors. DCC officers from a range of departments (assets, planning, town and villages regeneration, Transformation and Partnerships etc) continue to hold bi-weekly meetings with the four anchor tenants and SEW CIC directors to ensure the restoration project is delivered within the terms and conditions of the lease.

Food for Thought

• The foodbank store has outgrown its current base and will be temporarily moving to Nettlesworth Community Centre. This will not have any impact on the people who receive the packages as they are delivered or can still be collected from the SYP building. The hot meals are now being cooked from The Fells on a Tuesday and Nettlesworth Community Centre on a Thursday. 12 of the men who live in the accommodation at The Fells attended a full day Food Safety level 2 accredited course and will now have the option of progressing to start a catering qualification. Thank you to Cool Blue Consultancy for their support to deliver this training for me.

Housing Acquisitions

• DCC Buy to Lease scheme and Local Lettings Agency to DCC are proposing to take over flats in Ripley Court, Reeth Court and Ripon Court to offer the tenants increased support. The info they have provided is "The clients we house would receive 5 hours per week Housing Management Support from our officers as well as continuing to work with any other support services they may already be working with and would be signposted to any other services where a need is identified for additional support. This means that we will be able to assist them to develop their tenancy skills until they are ready to live independently. Providing this level of management also means that any issues arising can be quickly addressed"

		There have been ongoing issues with some tenants at these addresses so increased support should benefit the tenants and the community. School Benevolent Fund • The aim of this fund is to provide financial assistance to families in need to purchase shoes and coats for school children. Thank you to everyone who is volunteering their time to support residents in the Sacriston Division. The time you give is greatly appreciated.
